## SERVICE AGREEMENT

AGREEMENT made this day, \_\_\_\_\_, between **THE CITY OF EVANT WATER DEPARTMENT**, organized under the laws of **TEXAS RURAL WATER ASSOC. AND THE STATE OF TEXAS** (here called **CEWD**) and \_\_\_\_\_ (here in after called the **CUSTOMER**).

### **Witnessed:**

The **CEWD** agrees to sell and deliver water to the **CUSTOMER** and the **CUSTOMER** agrees to purchase and receive water from **CEWD**, in accordance with the bylaw and regulations of the **CEWD** as amended from time to time by the **CEWD**.

The **CUSTOMER** shall pay the **CEWD** for service there under the **RATES** and upon the **TERMS** and **CONDITIONES** set forth in the rate schedule adopted by the **CEWD'S CITY COUNCIL** acting as **THE BOARD OF DIRECTORS**.

The **CUSTOMER** is responsible to pay the **CEWD** for a damaged meter box, after it has been replaced for a third time.

The **CEWD'S CITY COUNCIL/BOARD OF DIRECTORS** has the **AUTHORITY** to establish billing practices and therefore **RESOLVED** that billing be done of the first of the month with bill due by the 15<sup>th</sup> day of the month, at the close of the business day. On the 16<sup>th</sup> day of the month, a \$25.00 late charge will be added to the bill. Meters will be read in the 20<sup>th</sup> of the month, (except holidays and weekends). Delinquent Meter/**CUSTOMER'S** services will be disconnected when the meter is read. A reconnect fee of \$25.00 will be charged to reestablish services. Only one bill will be sent each month; second or late notices will not be mailed to **CUSTOMER'S**.

All water meters will be furnished and installed by the **CEWD**. The meter and/or connection is for the sole use of the **CUSTOMER** and is to serve water to only one dwelling or only one business, and **DOES NOT** permit the **EXTENSIONS** of pipe or pipes to transfer water from one property to another, nor share, resell, or sub-meter water to any other person, dwelling business, property, etc.

In the event the total water supply be insufficient to meet all of the needs of the **CUSTOMER**, or in the event there is a shortage of water, the **CEWD** may pro-rate the water available among the various **CUSTOMER'S** such basis as in deemed equitable by the **CITY COUNCIL/BOARD OF DIRECTORS**, and may also prescribe a schedule of hours covering the use of water for garden purposes by particular **CUSTOMERS** and require adherence therefore to prohibit the use of water for garden purposes; provided that, if at any time the total water supply be insufficient to all the needs of the **CUSTOMER**, the **CEWD** must first satisfy the needs of the **CUSTOMER** for domestic purposes before supplying any water livestock purposes and must satisfy the needs of the **CUSTOMER** for both domestic and livestock purposes.

The **CUSTOMER** shall install, at his/her own expense, a service line with a shut-off valve from the water meter and/or sewer connection to the point of use.

The **CUSTOMER** shall hold the **CEWD** harmless from all claims or demands for damage to real or personal property occurring from the point the **CUSTOMER** ties onto the water meter to the destination of the line installed by the **CUSTOMER**. The **CUSTOMER** agrees to grant to the **CEWD** an easement of right-of-way for the purpose of installing, maintaining, and operating such pipelines, meters, valves, and any other equipment which may be deemed necessary for the **CEWD** on such form as is required by the **CEWD**.

The **CEWD** shall have all the right to locate a water service meter and the pipe necessary to connect the meter on the property of the **CUSTOMER** at a point to be chosen by the **CEWD**, and shall have access to its property and equipment located upon the **CUSTOMER'S** premises at all reasonable time for any furtherance of business operating, and upon discontinuance of service shall have the right to remove any of its property from the **CUSTOMER**.

The CEWD authorized employees shall have the right to have access to the CUSTOMER'S property or premises at all reasonable times for the purpose of inspecting for violations between the CEWD system and any unknown or non-potable water supply.

**PLUMBING RESTRICTIONS:**

The following undesirable plumbing is prohibited by STATE REGULATIONS.

A. No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an airgap or an appropriate backflow prevention device.

B. No cross-connection between the public drinking water supply and a private water system is permitted. These potential threats to the public drinking water supply shall be eliminated at the service connection by the installation of an airgap or a reduced pressure-zone backflow prevention device.

C. No connection which allows water to be returned to the public drinking water supply is permitted.

D. No pipe or pipe fitting which contains more than 0.25 percent lead may be used for the installation or repair of plumbing at any connection which provides water for human use.

E. No solder or flux which contains more than 0.2 percent lead can be used for the installation or repair of plumbing at a connection which provides water for human use.

\* The CUSTOMER shall immediately correct any undesirable plumbing practices on the premises.

\* The CUSTOMER shall at his expense, property install, test, and maintain any backflow prevention device required by the CEWD. Copies of all testing and maintenance records shall be provided to the CEWD.

\* The CUSTOMER will maintain a copy of this agreement if requested.

**ADDITIONALLY.**

I/ We do affirm that all customer information required by the CITY OF EVANT and thus submitted, is accurate and factual as of the date of this agreement, and that in the event of any material change as to billing address or customer responsibility, I/We will promptly notify the office of the CITY OF EVANT by phone, in person, or by mail.

**IF THE CUSTOMER FAILS TO COMPLY WITH THE TERMS OF THE SERVICE AGREEMENT, THE CEWD SHALL EITHER TERMINATE SERVICE OR PROPERTY INSTALL, TEST, AND MAINTAIN AN APPROPRIATE BACKFLOW PREVENTION DEVICE AT THE SERVICE CONNECTION. ANY EXPENSES ASSOCIATED WITH THE ENFORCEMENT OF THE AGREEMENT SHALL BE BILLED TO THE CUSTOMER.**
